Terms and Conditions

- Exclusive Photographer.** The Photographer will be the exclusive photographer retained by the Client for the purpose of photographing the wedding. Family and friends of the Client shall be permitted to photograph the wedding as long as they do not interfere with the Photographer's duties and do not photograph poses arranged by the Photographer. The client must understand the photographer is not responsible for pictures capturing other photographers (family members and guest with cameras) in the photographs. The client will assume responsibility if any damage is done to photography equipment due to family and friends pushing, bullying, or shadowing the photographer.
- Deposits and Payment.** The Client will make a deposit to retain the Photographer to perform the services specified in this contract. 1/2 of the package is due when photographer is retained. 2/3 of the balance is due a week before the wedding. The final balance is due 2 weeks after the wedding. Once the order is placed please allow 20 business days for the photographer to receive, proof the order and package the order. Once the photographer has completed the order, at such time the deposit will be applied to reduce the total fees and the Client will pay the balance due. If the Client refuses delivery of the order or refuses to pay within thirty (30) days of this order, Client shall be in default and pay 20 dollars per every 10 days on the unpaid balance until payment is made in full.
- Cancellation.** If the Client cancels this Agreement before the wedding date, any deposit paid to the Photographer will not be refunded unless a death occurs to bride or groom, act of God, or unforeseen weather circumstances. The photographer will reschedule the client for act of god or weather circumstances. If the date is not available, the photographer will offer print credit to the Client. If Client cancels within thirty days of the wedding date and if the Photographer does not obtain another assignment for that date, liquidated damages will be charged in a reasonable amount not to exceed the deposit. Therefore no print credit will be issued.
- Photographic Materials.** All photographic materials, including but not limited to negatives, transparencies, proofs, are the exclusive property of the Photographer. The Photographer will make proofs and/or previews available to the Client for the purpose of selecting photographs within (30) business calendar days of the wedding date, please be aware that it could take a little longer on our peak wedding seasons. The proofs and/or previews are considered to be on loan and, if not returned within fourteen (14) days of receipt by the Client, there will be a charge of \$150.00 applied to the account. This fee does not apply to viewing the proofs online.
- Copyright and Reproductions.** The Photographer owns the copyright of all images created and has the exclusive right to make reproductions. The Photographer will only make reproductions for the Client or for the Photographer's portfolio, samples, self-

promotions, or for display. The client will be given permission to have prints made if it is part of the package.

- ❑ **Client's Usage.** The Client is obtaining prints for personal use only, and shall not sell said prints or authorize any reproductions by parties other than the Photographer. Photographer must authorize the use of prints for newspaper announcements of the wedding.
- ❑ **Failure to Perform.** If the Photographer cannot perform this Agreement due to a cause beyond the control of the parties, or due to Photographer's illness, then the Photographer will return the deposit to the Client but will otherwise have no further liability with respect to the Agreement. The photographer will help the client seek other services but will not be held liable for any other contracts or services for the photographer or company the client chooses. This limitation on liability also applies in the event that photographic materials are damaged in processing, lost due to camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event the Photographer fails to perform for any other reason, the Photographer shall not be liable for any amount in excess of the retail value of the Client's order.
- ❑ **Photographer.** The Photographer may substitute another photographer to take the photographs in the event of Photographer's illness or of scheduling conflicts. In the event of a substitution, Photographer warrants that the photographer taking the photographs is a competent professional.
- ❑ **Inherent Qualities.** Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes. Client releases Photographer from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
- ❑ **Photographer's Price List.** The charges in this Agreement are based on the Photographer's Price List. These prices will be in effect for one year from the date of the wedding. Orders placed after the 1-Year anniversary date will be charged according to
to
The Photographer's most current price list.
- ❑ **Limit of Assurance.** This contract for wedding photography does not in any way guarantee the satisfaction of the client for the images that will be taken. Limitations on location, proximity to the ceremony or other events. Sanctuary/reception lighting and guest interference can affect the final product, and these situations are often beyond the control of the photographer. The photographer agrees to put forth his/her best effort with respect and enthusiasm for your event, and the images will reflect the client in the best possible way within the photographer's ability.
- ❑ **House Rules.** If the photographer is limited by the guidelines of the ceremony official or reception site management. Client agrees to accept the technical results of the imposition on the photographer. Negotiation with the officials for moderation of guidelines is the client's responsibility.
- ❑ **Lunch or Meal break.** The client is not obligated to provide photographers meals but if the event is 4-6 hours or longer the photographers will be grateful if a meal is provided or client must allow photographer or photographers to leave the event for lunch or dinner.
Photogenix Images policy is not to shoot guest or wedding party during meal services. At this time period the photographers will most likely break for meals.
- ❑ **Other Advertisement.** The client will accept responsibility of guest and other outside photographers. Photogenix Images is the exclusive photographer no other advertisement such as business cards or flyers should be displayed during the event. If

violation occurs the photographer has the right to remove items and or leave the event.
The client will still be responsible for all fees and balances.

- **Misc.** This Agreement assumes the entire understanding of the parties. Any modifications of this Agreement must be in writing and signed by both parties.
